Earth Day 2024 - In Mashpee

Saturday, April 20, 2024, 9am to 1pm Textile Recycling, Secure Shredding, and Composting Event

Mashpee Senior Center, 26 Frank E Hicks Drive, Mashpee

This free event is co-sponsored by the Mashpee Environmental Coalition and Mashpee Department of Public Works. As it is now illegal to discard any/all items made of textiles in the trash, residents can drop off bags of clean and dry **bedding**, **clothes**, **shoes**, **towels**, **curtains**, **handbags**, **accessories**, **and even stuffed animals** – including those that are ripped, frayed, and stained. At the same time, a **Secure Shredding Company** will be onsite to safely dispose of documents containing personal and confidential information. And, for those interested in composting, information plus a **free kitchen food scrap bucket** will be distributed by Mashpee DPW, with home compost bins also available for purchase. Special and Annual Town Meeting

Mashpee High School, 500 Old Barnstable Road, Mashpee

A number of important issues will be decided by Mashpee voters at this meeting. Articles pertaining specifically to Mashpee's Wastewater Management program include Articles 4, 5 and 6 of the Special Warrant, and Article 4 of the Annual Warrant. At the April 1st Mashpee Select Board meeting, Town Manager, Rodney Collins presented a summary of funding sources as well as the impact to residents if Mashpee's Wastewater Plan, Phase 2 is approved. Information Items

Waterways Updates

- At its meeting on April 4th, the Mashpee Conservation Committee unanimously approved a preliminary proposal for reconfiguring the **Mashpee-Wakeby Pond** Boat Ramp, presented by representatives of APCC and the Horsley-Whitten Group. The proposed changes are aimed at reducing stormwater runoff into the pond.
- According to the Town of Mashpee website, dredging of the Popponesset Bay Approach Channel has been completed. Additional information may be found at: <u>https://www.mashpeema.gov/home/news/popponesset-approach-channel-dredge-update</u>.
- As of April 15, 2024, **Santuit Pond** now has a 10hp limit. Direct abutter permit holders will receive a waiver until April 15, 2025. A notice to this effect is posted on Mashpee's Natural Resources webpage at: <u>https://www.mashpeema.gov/natural-resources</u>. The reduction in hp is intended to result in less phosphorus being churned up from the bottom of this shallow pond.
- As reported by *The Enterprise* on April 5th at www.capenews.net, Falmouth has joined Mashpee and Sandwich in approving the Intermunicipal Agreement aimed at addressing nitrogen pollution in **Waquoit Bay**.

Recycling News

Between April 1 and June 30, Mashpee residents may drop off their**Boat Shrink Wrap** for recycling at one of four transfer stations across Cape Cod, including Falmouth and Bourne.
