- funding for a Phase II Sewer Project study in support of the Waquoit Bay watershed; and
- the purchase and conservation of over 7 acres of largely undeveloped land on the southern end of Johns Pond.

## Information Items

#### Waterways in the News

As recently shown on the Association to Preserve Cape Cod (APCC) website, the cyanobacteria advisories for **Ashumet Pond** and **Santuit Pond** were both lifted based on water quality samples taken last month.

At a recent meeting of Friends of Ashumet Pond (FOAP), JBCC Contractor, Jonathan S. Davis, P.E., Sr. Environmental Engineer | Cherokee Federal, provided an historical overview of **Ashumet Pond** from the perspective of JBCC, and announced that plans are underway to start addressing PFAS levels.

As part of the Cape Cod Commission's Freshwater Initiative, three Mashpee ponds have been selected for their extensive 3-year study: **Johns Pond**, **Moody Pond**, and **Santuit Pond**. The long-awaited **Mashpee-Wakeby Pond** Diagnostic Study is scheduled for completion sometime in November, with a presentation to the Mashpee Select Board to follow. Both dates have yet to be confirmed.

Per the Town of Mashpee website, <u>www.mashpeema.gov</u>, the closure of the **Edward A. Baker Boat Ramp** at **Pirate's Cove** has been extended, with an expected reopen date of November 30.

Mashpee's **oyster season** opened on November 1st, and is scheduled to end March 31st, with oysters available to harvest at **Ockway Bay** boat ramp and **Seconsett Causeway**.
